Open Dance Project is an ensemble-driven dance theater company dedicated to developing & presenting world class dance theater experiences in Houston & serving as a cultural resource through its engaging & enlightening education & community programming.

Dance Theater Performances: Conceived, developed & presented livestream productions, dance films, & outdoor performances for the general public at venues including MATCH-Midtown Arts & Theater Center Houston & Houston Botanic Garden in collaboration with Musiga. Productions included "Inside/Out" a weekend of dance films created in collaboration with Musiga; two livestream productions of ODP's latest immersive dance theater work "All the Devils are Here: A Tempest in the Galapagos" co-presented by Houston based DiverseWorks & Evanston, Illinois based Studio5. 248 audience members from 15 different states joined us for the two livestreamed productions on May 15 & 16. In fall of 2021, ODP re-envisioned its dance film collaboration with Musiga into its first live performances in 18 months at Houston Botanic Garden. These four sold out performances of "Still We Tend" took audiences on a journey through Houston Botanic Garden that was guided by ODP performers & Musiga musicians.

Dance Theater Classes & Workshops: Developed & led classroom workshops, residencies, performances, & professional development workshops (teacher trainings) in Houston area studios, schools, afterschool programs and parks that served over 3,000 students & teachers. At the beginning of 2021 some programs were recorded & offered online in order to follow COVID safety guidelines. ODP developed & distributed an outline platform of instructional arts integration videos connected to performance clips as a free resource to K-12 teachers.

Guest Artist Residencies/Artist Exchanges: ODP toured to Chicago to offer a residency at Studio5 & Northwestern University offering workshops & classes & a showing of "All the Devils Are Here: A Tempest in the Galapagos"; ODP sponsored 4 apprentices in our professional apprentice program throughout 2021 & hosted guest artists from Musiga who performed live at "Still We Tend" performances at Houston Botanic Garden in September 2021.
